

**CONFERENCE ON THE GREAT MOTHER AND THE NEW FATHER
PARTICIPATION WAIVER AND RELEASE 2024**

This Participation Waiver and Release (“Release”) is given by the undersigned Participant (the “Participant”) and the following individuals and business entities: Tor Gul, Inc., a Vermont nonprofit corporation (“Tor Gul”) and Camp Wavus of Nobleboro, Maine (“Camp”) and Tor Gul’s and Camp’s directors, officers, employees; and volunteers (hereinafter the “Releasees”). This Release is a requirement and condition precedent for Participant’s participation in a Conference on the Great Mother and the New Father (the “Conference”) to take place May 17-24, 2024 at Camp Wavus, and any other activities offered, conducted, provided, organized, or sponsored by the Releasees or which take place at Camp during the time period specified.

In consideration of the opportunity to attend and participate in the Conference, the Participant agrees as follows:

1. **Inherent Risks:** The Participant acknowledges and understands that certain activities that may occur during the Conference, including but not limited to boating, hiking, and swimming (“Activities”) are inherently dangerous activities and that those dangers and conditions are inherent to the Activities themselves and could result in damages to property or injury, harm, or death to participants. Despite these inherent risks the Participant has chosen to attend the Conference, and may choose to participate in some of these Activities.
2. **Release and Waiver:** The Participant understands the risks and dangers inherent in participation in the Conference generally and the Activities available during the Conference and hereby waives, releases, any claim or seek any recovery from the Releasees, or any of them, for any claim for damages due to illness, disease, personal injury or death or damage or loss of personal property (“Claims”) resulting from these activities. The Participant hereby further releases, holds harmless, and discharges the Releasees, collectively and individually, from any and all Claims now existing or which may in the future occur or result, directly or indirectly, from participation in the Conference or any Activities. The Participant further agrees not to sue any of the Releasees for any Claims. This Release and Waiver are intended to be as broad as the law allows and specifically covers all Claims that may be based on the fault or negligence of the Releasees.
3. **Consent to Emergency Medical Care:** In case of any injury to the Participant while attending the Conference, the Participant hereby consents to and authorizes any of the Releasees, or their agent, to seek emergency medical care and treatment for the Participant, including arranging for transportation to a medical facility and consenting to reasonably necessary emergency treatment, medication or surgery recommended by a medical professional. The Participant acknowledges that they are solely responsible for payment of any medical costs or expenses incurred on behalf of the Participant.

THIS DOCUMENT CONTAINS EXPRESS ASSUMPTION OF RISK, A PROMISE NOT TO SUE, AND A WAIVER AND RELEASE OF ALL CLAIMS. THE UNDERSIGNED HAS BEEN GIVEN AN OPPORTUNITY TO READ AND CONSIDER THIS AGREEMENT AND SIGNS IT WILLINGLY.
